

**FENSTANTON PARISH COUNCIL  
BURIAL GROUND  
TABLE OF FEES**

**EFFECTIVE from 1 April 2019**

Fees, payments and sums fixed and settled under Section 34 of the Burial Act 1852 as amended by the Local Government Act 1972 and the Local Authorities Cemeteries Order 1974.

The fees for items under Parts 1, 2 and 4 do not include payment for digging of a grave.

<b>PART 1 : INTERNMENT IN A GRAVE</b>	
	<b>£</b>
Of the body of a still born or of a child whose age at the time of death did not exceed 1 year	<b>NIL</b>
Fees no longer apply to the burial of children up to the age of 18	<b>NIL</b>
Of the body of a person whose age at the time of death is 18 years or over	<b>396</b>
For the interment of <b>cremated remains</b> in a <b>single grave</b> of which an exclusive Right of Burial has been granted	<b>165</b>
<b>PART 2 : EXCLUSIVE RIGHT OF BURIAL IN AN EARTHEN GRAVE</b>	
For the Exclusive Right of Burial from date of conveyance in an earthen grave 2740mm X 1220mm	<b>518</b>
An option to pre purchase the Exclusive Right of Burial for 25 years can be taken for a fee of £100 at the discretion of the Burial Board / Parish Council dependent upon available plots with a second fee of £100 to extend this option if required for a further 25 years. These fees to be deducted from the final charge.	<b>100</b>
<i>A double burial in a single plot is available at the same fee as above and the above conditions apply.</i>	
<b>The purchase of an Exclusive Right of Burial shall not permit the sole interment of cremated remains.</b>	
<b>PART 3 : MEMORIALS</b>	
For permission to erect a headstone not exceeding 1060mm in height, in accordance with the National Association of Memorial Masons (NAMM) standards or by an NAMM accredited stone mason. <b>Stone kerbs not permitted.</b>	<b>214.50</b>
For permission to erect a headstone not exceeding 1060mm in height and not in accordance to NAMM standards or not by an accredited NAMM stone mason. <b>Stone kerbs not permitted.</b>	<b>451</b>
<i>The fee for permission to erect a headstone includes permission for the first inscription. For each inscription after the first, an additional fee is payable.</i>	<b>44</b>
<b>A headstone may only be erected on a plot for which Exclusive Right of Burial has been granted.</b>	
<b>Themed memorials deemed by the Parish Council likely to cause offence are not permitted.</b>	

**NOTES:**

The Parish Council, in accordance with other Burial Authorities, does not accept any responsibility for memorials. The responsibility for maintaining and ensuring the memorial remains in a safe condition remains with those having the memorial erected. However, at its own discretion the Parish Council will carry out urgent remedial work where there is a Health & Safety risk and endeavour to contact the relevant family after the work has been carried out to request reimbursement of the expense.

The fees, payments and sums set out above apply where the person to be interred or in respect of whom the right is granted is (or immediately before death was) an inhabitant or parishioner of the Parish of Fenstanton or, in the case of a stillborn child, the parents (or one of them) are, or at the time of interment, were inhabitants or parishioner of the Parish.

In all other cases the fees, payments and sums will be **doubled** except that those set out in Parts 1 and 3 will not be doubled where the Exclusive Right of Burial in the grave in question was acquired at the single fee as set out in Part 2.

At a meeting of the Fenstanton Burial Board on 25 April 2019 this Table of Fees was fixed and approved.
